#### **ORDINANCE NO: 2024-17**

# AN ORDINANCE APPROVING AND AUTHORIZING THE EXECUTION OF THE AGREEMENT BETWEEN KEN CONAWAY LLC AND THE VILLAGE OF LAKEVIEW, OHIO, AND MAYOR'S APPOINTMENT OF FLOOD PLAIN ADMINISTRATOR DESIGNEE AND DECLARING AN EMERGENCY

WHEREAS, the Mayor, the appointed Village Flood Plain Administrator, and Village Solicitor, recommend it is in the Village's best interest to contract with Ken Conway LLC, to obtain the professional services of Ken Conaway for legally mandatory property damage assessment for structures in the wake of the March 14, 2024 tornado disaster and to otherwise appoint Conaway as Mayor's designee in the role of Flood Plain Administrator; and

WHEREAS, while an additional expense to the Village, independent structural evaluation is in the best interest of the Village of Lakeview where property owners are challenging the Significant Damage Assessments as required by FEMA for structures with any part in the new Flood Zones; and

WHEREAS, Mr. Conaway is very experienced to immediately bring benefit to the Village, see resume attached as Exhibit A; and

WHEREAS, compliance with state and federal law is mandatory; and

WHEREAS, permitting to rebuild cannot be issued until mandatory post-tornado storm assessments are completed; and

WHEREAS, it is in the Village's best interest to assist with rebuilding as timely as possible.

### BE IT RESOLVED by the Council of the Village of Lakeview, Ohio:

SECTION I. The Village desires to enter into a service agreement with Ken Conway LLC, attached as Exhibit B.

SECTION II. All required Village officials are hereby authorized to execute the agreement, including the Mayor, Administrator, and Fiscal Officer.

SECTION III: The Village Flood Plain Administrator is authorized to direct the services to be performed by Ken Conaway under the agreement as her designee.

SECTION IV: It is found that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council
