ORDINANCE NO: 2024-22

AN ORDINANCE APPROVING AND AUTHORIZING THE EXECUTION OF THE INDEPENDENT CONTRACTOR AGREEMENT BETWEEN GARY BIAS AND THE VILLAGE OF LAKEVIEW, OHIO, AND DECLARING AN EMERGENCY,

WHEREAS, The Village and Gary Bias desire to enter into a contract to adequately compensate Gary Bias for his performance as Village Zoning Enforcement Officer in light of current circumstances; and

WHEREAS, as a result of the F3 tornado that struck the Village of Lakeview on March 16, 2024, needed zoning services have increased substantially and the demands on the Village Zoning Enforcement Officer will continue to be significant throughout the recovery process; and

WHEREAS, Gary Bias has shown interest in continuing on as the Village's Zoning Enforcement Officer, under the attached proposal Independent Contractor Agreement, marked Exhibit A; and

WHEREAS, continuing to employ Gary Bias, Zoning Enforcement Officer, under these new terms and conditions as an independent contractor is in the best interest of the Village of Lakeview; and

WHEREAS, it is in the Village's best interest to continue the services of Gary Bias as Zoning Enforcement Officer under this new contract, a contractual employee with great historical knowledge.

BE IT RESOLVED by the Council of the Village of Lakeview, Ohio:

SECTION I. The Village desires to enter into the Agreement with Gary Bias, attached as Exhibit A.

SECTION II. All required Village officials are hereby authorized to execute the agreement, including the Mayor, Village Administrator, and Fiscal Officer.

SECTION III: It is found that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

SECTION IV: This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety in the Village of Lakeview, as additional assistance with mandatory inspections resulting from the March 14, 2024 tornado damage is immediately needed to remain in compliance with permitting under FEMA regulations. This Ordinance shall be in immediate effect or on the earliest date allowed by law if it receives a two-thirds vote of all members elected to the Village Council.
